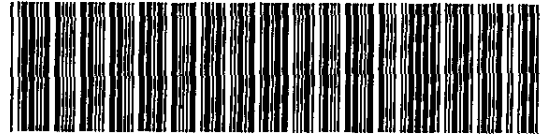

ARTICLE I - NAME AND BUSINESS ADDRESS

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE
