To Whom It May Concern:

Steven L. Brown, P.A., a for profit corporation, was established in September 2005. Recently, our firm was contacted by the President of Steven L. Brown, P.A. to provide accounting services for the new corporation. We were contacted in August, after the May 1 annual report filing deadline, at which time we informed our new client that an annual report form should have been filed for the year 2006.

The corporation is a new business that began operations in January 2006, and our client was not aware that an annual report had to be filed prior to May 1. Our client made several appointments with his former CPA earlier this year to ensure he was complying with corporate filing requirements; however, his former accountant canceled the appointments and did not inform our client of the need to file the corporation's annual report.
