**ARTICLES OF INCORPORATION
OF**

ROYAL INSURANCE COMPANY, INC.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is Royal Insurance Company, Inc.

ARTICLE II

The street address of the principal office of the Corporation is 9090 Alt A1A, North Palm Beach, Florida 33403. The mailing address of the principal office of the Corporation is P.O. Box 222461, West Palm Beach, Florida 33422.

ARTICLE III

The general purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporation Act.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 100, par value \$.01 per share, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

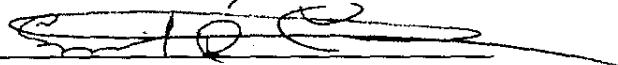

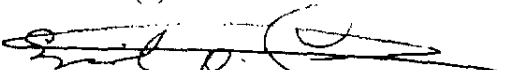
