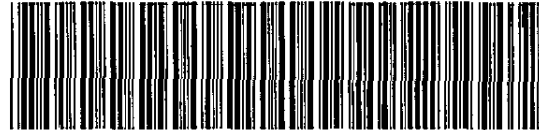

ARTICLE I

Name

- 1.1 The name of the corporation is Deadline Mortgage Processing, Inc.

ARTICLE II

Duration

- 2.1 This corporation shall have perpetual existence commencing on September 10, 2005 as a date being within five (5) business days prior to the date of filing these Articles of Incorporation with the Department of State of Florida.

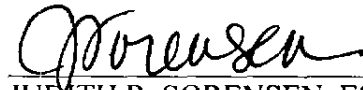

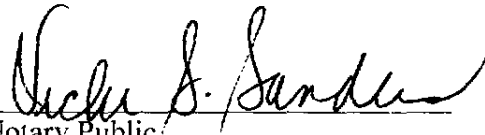
