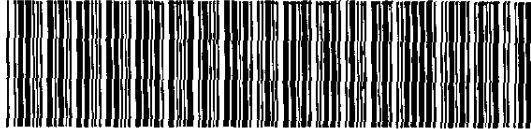

The undersigned incorporator, for the purpose of forming Paradise Of Broward Corporation, under the laws of the State of Florida, adopts the following Articles of Incorporation:

ARTICLE I - NAME

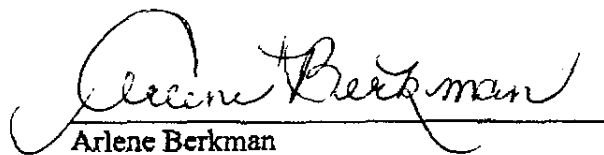

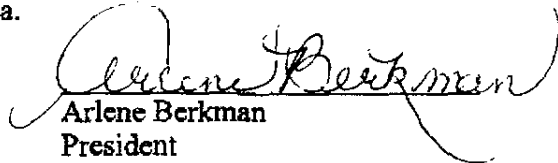

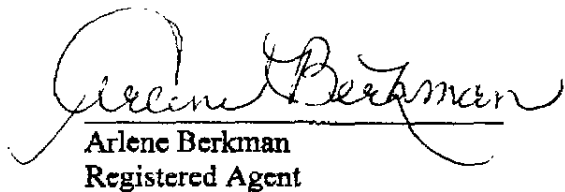
