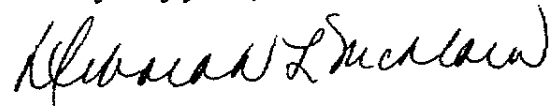

ARTICLE I.
NAME

The name of this corporation is ANSWER FOR YOU, INC.

ARTICLE II.
PRINCIPAL OFFICE

DURATION; EFFECTIVE DATE
