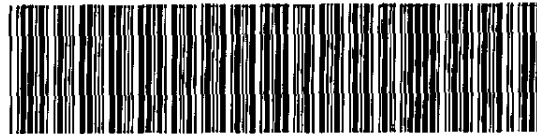

The undersigned, acting as Incorporator, desiring to form a corporation for profit pursuant to the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

**ARTICLE I**  
**NAME**

The name of this corporation is E.J. ENVIRONMENTAL SERVICES, INC.

**ARTICLE II**  
**ADDRESS OF PRINCIPAL OFFICE**


One purpose of this corporation shall be to operate an environmental consulting business and all other corporate purposes allowed by law.


