Mayelin Moner, 9105 Taft Street, Pembroke Pines, Florida 33024, shall be the new Registered Agent/Registered Office of the corporation.

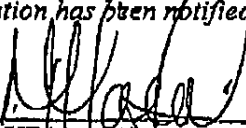
The Amended Articles and each Amendment described herein are adopted and shall be effective as of the date written below.
