ARTICLES OF INCORPORATION OF GRAETZER.COMMUNICATIONS CORP

The undersigned incorporator, for the purpose of forming a corporation pursuant to the Florida Business Corporation Act, hereby adopts the following Articles of incorporation:

ARTICLE 1. NAME.

The name of the corporation is Graetzer.Communications Corp.

ARTICLE 2. PRINCIPAL OFFICE AND MAILING ADDRESS.
