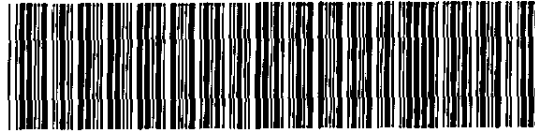

*****ARTICLE ONE*****
