Article I: Name of the corporation

The name of the corporation shall be: Multi Cultural Daycare Center, Inc.

Article II: Business purposes & location

The corporation has been formed in order to organize and operate a daycare center at one of the facilities of the First Haitian Baptist Church of Orlando, Inc., located at the following address:

4701 Lenox Boulevard Orlando FL 32811

First Haitian Baptist Church of Orlando, Inc., and Emmanuel Lamy have agreed to join their resources to elaborate an early learning program setting that shall take into account the cultural environment at home, of the Hispanic-American and Haitian-American children in our community. First Haitian Baptist Church of Orlando shall make available a 4900 square feet hall (70' X 70') for the development of the program, and Emmanuel Lamy shall provide the technical skills and structures necessary to the implementation of the program. First Haitian Baptist Church of Orlando, Inc., and Emmanuel Lamy have furthermore agreed to equally endorse the initial funding of the project. Article III: Shares and initisal subscriptions

The corporation shall issue a total of 30,000 shares, initially valued at \$1.00/share, of which First Haitian Baptist Church subscribes for 15,000 and Emmanuel Lamy for 15,000.

Subscriptions are due upon registration of the corporation with the Florida department of state, and the funds shall be deposited in the corporation bank account as soon as the federal tax authorities have issued a Federal Employer Identification Number to the corporation, and the corporation can open its own account.

Article IV: Election of preemptive rights

The shareholders elect to exercise preemptive rights to acquire the corporation unissued or treasury shares, notwithstanding the rights to assign unissued shares to active officers and employees of the corporation as incentives or compensation for services. Assignment of the corporation's unissued or treasury shares, however, is subject to unanimous votes of the shareholders.

Article V: Officers, board of directors & corporate council

The daily business of the corporation shall be administered by corporate officers appointed by the shareholders. The corporate office team shall include:

- A. A president
- B. A vice-president
- C. A secretary
- D. A treasurer

Descriptions of those functions are set in the corporation bylaws. For the time when the number of shareholders does not exceed 100, the corporation shall not be using the service of a board of directors. Instead, a corporate council, under the direction of the president, acting as council chairman, shall take to votes the corporate decisions. The corporate council is vested with all the prerogatives, rights, and obligations associated with the functions of a board of directors. The council shall comprise the active corporate officers, and may include other shareholders' delegates. The shareholders shall elect corporate officers and council delegates during the annual shareholders meeting, according to the rules defined in the corporation bylaws. Whenever the number of

shareholders reaches 101, the shareholders shall convoke a special meeting to elect directors and form the board of directors which, then, shall take over the corporate council
