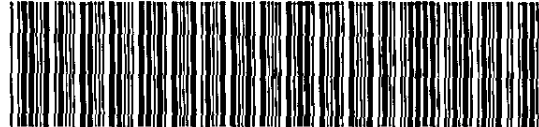

**ARTICLES OF INCORPORATION
OF
HURRICANE DEBRIS REMOVAL, INC.**

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act hereby adopt the following **ARTICLES OF INCORPORATION**:

**ARTICLE ONE
NAME**

The name of the corporation is **HURRICANE DEBRIS REMOVAL, INC.**

**ARTICLE TWO
DURATION**

This corporation shall commence existence as of October 3, 2005.

**ARTICLE THREE
PURPOSE**

The corporation may transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

**ARTICLE FOUR
CAPITAL STOCK**
