

Pursuant to the Florida Business Corporation Act (the "Act"), SENIORCARE COMMUNITY PHARMACY, INC., a Florida corporation (the "Corporation"), does hereby amend its Articles of Incorporation as follows:

**FIRST:** The name of the Corporation is Seniorcare Community Pharmacy, Inc.

**SECOND:** The Corporation was originally incorporated and the original Articles of Incorporation of the Corporation were filed with the Florida Department of State on September 15, 2005, with an effective date of September 15, 2005.

**THIRD:** The document number of the Corporation is P05000127288.

**FOURTH:** Article VII of the Corporation's Articles of Incorporation is hereby deleted in its entirety and replaced with the following:
