**ARTICLES OF INCORPORATION  
OF  
NAUTICAL ACCESS, INC.**

**ARTICLE I  
NAME**

The name of the Corporation is NAUTICAL ACCESS, INC.

**ARTICLE II  
DURATION**

The Corporation shall have perpetual existence.

**ARTICLE III  
PURPOSE**

The Corporation is authorized for the following purposes: internet service provider (ISP) providing wireless internet access ("hot spots") to marinas, RV parks and other similar locales, and to "retail" customers at such locations; to engage in any activity or business incidental to or related to those activities or businesses set forth herein; to acquire and hold stock in any corporation; to engage in joint ventures and partnerships, as a limited or general partner; and to acquire, own, hold, manage, mortgage, improve, lease, sell, exchange, transfer, and otherwise deal with real, personal, and intangible property wherever situate; and to carry out said purposes in any State, territory, district, or possession of the United States, or in any foreign country.

CAPITAL STOCK**

The Corporation is authorized to issue 7,500 shares of capital stock of the par value of \$1.00 which shall be designated "Common Shares", and all of which shall have the same rights and privileges.
