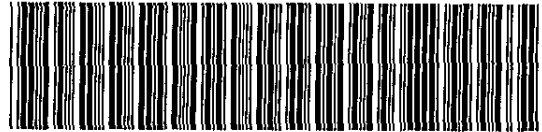

ARTICLES OF INCORPORATION

OF

**ARTICLE I
NAME**

The name of this corporation is: **SHURZ CLEAN, INC.**

**ARTICLE II
DURATION**

This Corporation shall exist perpetually.

POWERS

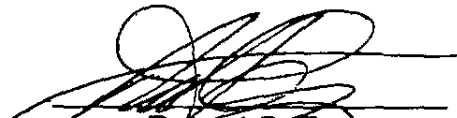
This Corporation shall have all of the Corporate powers enumerated by the Florida General Corporation Act, and as otherwise provided by law.

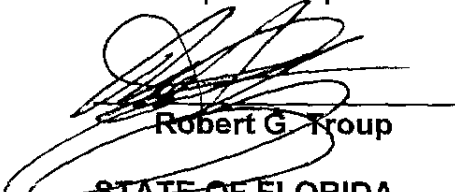

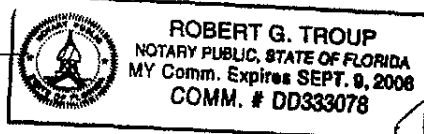
