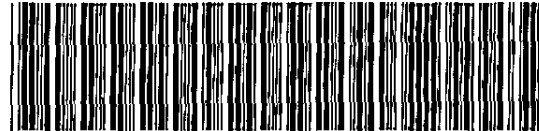

CORPORATE NAME

The name of this Corporation is Coker Racing Enterprises, Inc.

ARTICLE II
INITIAL PRINCIPAL PLACE OF BUSINESS

ARTICLE III
NATURE OF BUSINESS AND POWERS

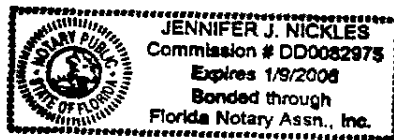

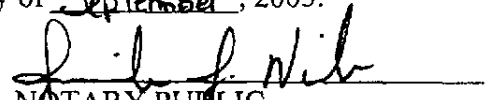
