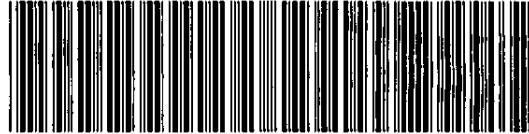

I hereby resign as President of Emerald Coast Connections of St. Petersburg, Inc. I assumed that title in March of 2009 at your request in the hope that my higher credit score might assist your loan broker, JGP Financial LLC., in obtaining a loan for your business. That did not prove to be the case. The validity of my acceptance of the position is questionable given my mental difficulties from my brain disease of neurosarcoidosis as witnessed by the Social Security Administration making your mother my representative payee of my disability payments. After twice having me examined by their doctors, the Administration determined I was not mentally qualified to handle my own money, hardly a qualification to be a corporate officer or to competently assume such a position.

The stress of the many lawsuits against Emerald and you are triggering attacks of my illness and I have to retreat from responsibilities for a while.
