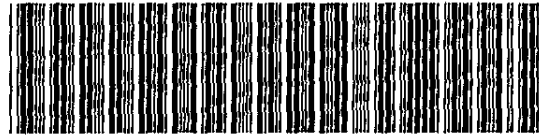



OF

The undersigned Incorporator to these Articles of Incorporation, a natural person, competent to contract, does hereby form a corporation for profit under the laws of the State of Florida.

ARTICLE I. CORPORATE NAME

The name of this corporation shall be LAVELL D. JOHNSON CONCRETE, INC.

ARTICLE II. INITIAL PRINCIPAL OFFICE

The street address, and the mailing address of the initial principal office of the Corporation is: 1208 Rule Street, Pensacola, Florida 32534.

ARTICLE III. CAPITAL STOCK

The number of shares the corporation is authorized to issue is 5,000. No preemptive rights are to be granted to shareholders.

ARTICLE IV. REGISTERED OFFICE AND INITIAL REGISTERED AGENT

The street address of the Corporation's initial registered agent, and the name of the initial registered agent is: Lavell D. Johnson, 1208 Rule Street, Pensacola, Florida 32534.

ARTICLE V. INCORPORATOR

ARTICLE VI. BOARD OF DIRECTORS

This corporation shall have ONE (1) director initially. The number of directors may be increased or diminished from time to time by by-laws adopted by the stockholders, but shall never be less than one (1).
