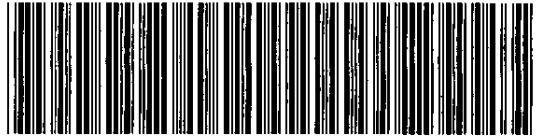

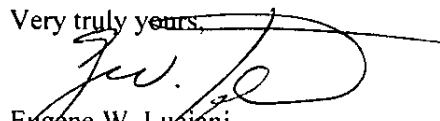

I.

The name of the corporation is "**Highwinds Wholesale Group, Inc.**"

Effective the date hereof, Article I of the Articles of Incorporation of Highwinds Wholesale Group, Inc. is amended to read as follows:

All other provisions of the Articles of Incorporation shall remain in full force and effect.

III.

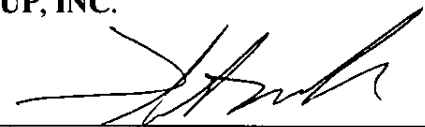
The changes made by these Articles of Amendment shall be effective upon the filing of these Articles of Amendment with the Florida Department of State.
