The undersigned, acting as sole incorporator, adopts these Articles of Incorporation and forms a profit corporation (the "**Corporation**") under the Florida Business Corporation Act (the "**Act**"), as follows:

**I.
Name**

The name of the Corporation is **Aboukir, Inc.**

**II.
Term of Existence**

The date when corporate existence will commence is September 12, 2005 in accordance with Section 607.0203(1) of the Act. The Corporation will have perpetual existence thereafter.

**III.
Principal Office**

The principal office and mailing address of the Corporation is 3510 West Leona Street, Tampa, Florida 33629.

**IV.
Capital Stock**

The Corporation is authorized to issue 10,000 shares of \$1.00 par value common stock, which will be designated Common Stock.

The Corporation will indemnify any director or officer or any former director or officer, to the fullest extent permitted by law.




