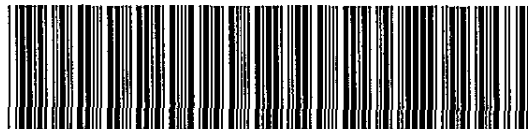

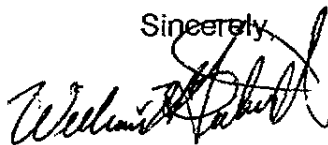

The undersigned WILLIAM H. FUTRELL does hereby make, subscribe, acknowledge and file these Articles of Incorporation for the purpose of becoming a corporation under the Laws of the State of Florida in compliance with Chapter 621, F.S. (Profit).

**ARTICLE I - NAME**

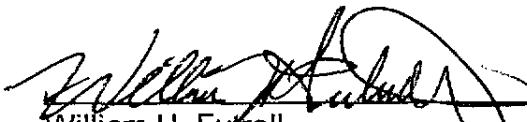
