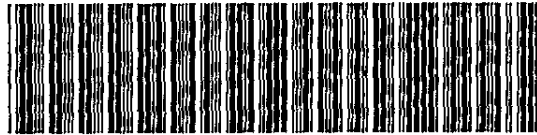

ARTICLES OF INCORPORATION
OF
RANDY DOWD PLUMBING SERVICES, INC.

ARTICLE I - NAME

The name of this corporation is RANDY DOWD PLUMBING SERVICES, INC., and the principal office or mailing address of the corporation is 201 Main Street W., Dundee, Florida 33838.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes, as now exists or may after be amended.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 500 shares of 1.00 par value common stock which shall be designated as "Common Shares."

ARTICLE V - PRE-EMPTIVE RIGHTS

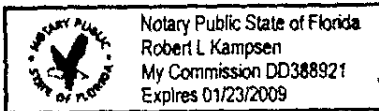





