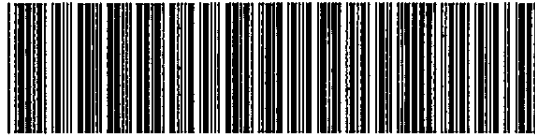



ARTICLE I


