ARTICLE I

Name

The name of the corporation shall be Flynn, Inc.

ARTICLE II

Duration

This corporation shall exist perpetually.

ARTICLE III

Purpose

This corporation is organized for the purpose of engaging in any or all lawful business for which corporations may be incorporated.

ARTICLE IV

Capital Stock

This corporation is authorized to issue 10,000 shares of \$.01 par value common stock, which shall be designated "Common Shares".

ARTICLE V

Preemptive Rights

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which she already holds, shall have the right to purchase her pro rata share thereof (as nearly as may be done without the issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI

Powers

This corporation shall have all of the powers enumerated in the Florida Business Corporation Act.

ARTICLE VII

By-Laws

The power to adopt, alter, amend or repeal By-Laws shall be vested in the Board of Directors and the shareholders.

ARTICLE VIII

Initial Registered Office and Agent

The street address of the initial registered office of this corporation is 740 West Indiantown Road, Jupiter, FL 33458, and the name of the initial registered agent of this corporation at such office is Dawn Flynn, who upon accepting this designation agrees to comply with the provisions of Section 48.091, Florida Statutes as amended from time to time, with respect to keeping an office open for service of process. The principal place of business or mailing address of this corporation is 740 West Indiantown Road, Jupiter, FL 33458.

ARTICLE IX

Initial Board of Directors

This corporation shall have one Director initially. The number of Directors may be either increased or diminished from time to time by the By-Laws. The initial director of the corporation shall be Dawn Flynn.


