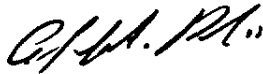

The Corporation initial Registered Agent and Principal Office in the STATE OF FLORIDA is:

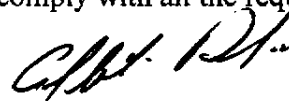

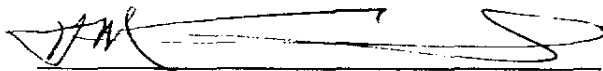
