ARTICLES OF INCORPORATION

OF

MARCUS VANZANT, P.A.

The undersigned, being a natural person licensed or otherwise legally authorized to practice real estate brokering desiring to form a professional corporation pursuant to the Professional Service Corporation Act and pursuant to the laws of the State of Florida, does hereby certify as follows:

ARTICLE I - NAME

The name of the professional corporation is: **MARCUS VANZANT, P.A.**

ARTICLE II - NATURE OF BUSINESS

The professional corporation is organized for the sole and specific purpose of rendering the same services to the public which are rendered by real estate brokers and the general nature of this business to be transacted by this professional corporation is as follows:

A. To engage in every phase and aspect of the profession of rendering the same professional services to the public that a real estate broker duly licensed under the laws of the State of Florida, is authorized to render but such professional services shall be rendered only through officers, employees and agents who are duly licensed under the laws of the State of Florida to perform such services.

B. To invest the funds of this professional corporation in real estate, mortgages, stocks, bonds or any other type of investment, and to own real and personal property necessary for the rendering of such professional services.

C. To do all and everything necessary and proper for the accomplishment of any of the

purposes of the attaining of any of the objects or the furtherance of any of the purposes enumerated in these Articles of Incorporation or any amendment thereof, necessary or incidental to the protection and benefit of the professional corporation, and in general, either alone or in association with other corporations, firms or individual to carry on any lawful pursuit necessary or incidental to the accomplishment of the purposes of the attainment of the objects or furtherance of such purposes or objects of this professional corporation.

The foregoing paragraphs shall be construed as enumerating both objects and purposes of this professional corporation; and it is hereby expressly provided that the foregoing enumeration of special purposes shall not be held to limit or restrict in any manner the purposes of this professional corporation otherwise permitted by law.

ARTICLE III - CAPITAL STOCK

The maximum number of shares of capital stock which this professional corporation shall be authorized to issue is Five Hundred (500) shares of common stock with a par value of One (\$1.00) Dollar per share.

ARTICLE IV - CAPITALIZATION

The amount of capital with which the corporation shall commence is Five Hundred and No/100 (\$500.00) Dollars which said amount has been fully paid in.

ARTICLE V - DURATION

This corporation shall have perpetual existence.

ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT

This corporation shall have one (1) directors initially. The number of directors may be either increased or decreased from time to time as provided in the by-laws, but shall never be less than one (1) and said corporation is authorized to have five (5) directors at any one time.
