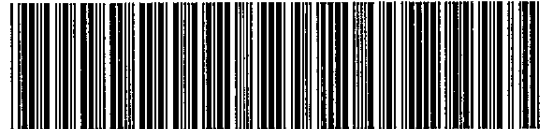

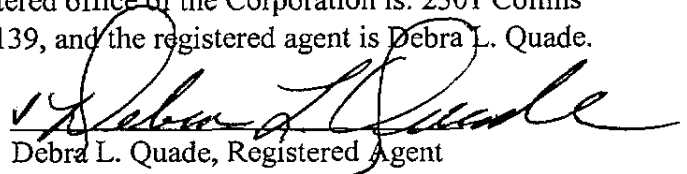

The undersigned incorporator for the purposes of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

- FIRST: The name of the Corporation is **Debra L. Quade, PA** (The Corporation).
- SECOND: The principal office address and mailing address of the Corporation is 2301 Collins Avenue, #724, Miami Beach, FL 33139
- THIRD: The Corporation is authorized to issue 7,500 shares of common stock, par value \$1.00 per share.
- FOURTH: The street address of the initial registered office of the Corporation is: 2301 Collins Avenue, #724, Miami Beach, FL 33139, and the registered agent is Debra L. Quade.

It is hereby expressly provided that the foregoing enumeration of a specific purpose shall not be held to limit or restrict in any manner the purpose of this corporation otherwise permitted by law.

The Corporation is also organized for the purpose of transacting such other lawful business for which corporations may be formed under Chapter 607 of the Florida Statutes, and in compliance with Chapter 621 of the Florida Statutes as a Professional Association.

- SEVENTH: The Corporation shall have one director initially and the number of directors may be increased or diminished from time to time as provided in the Bylaws but shall never be less than one. The name and address of the initial director of the Corporation is:

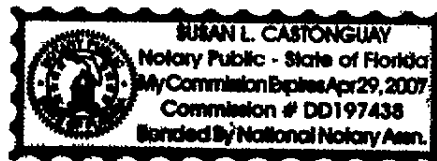
