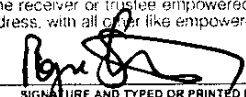

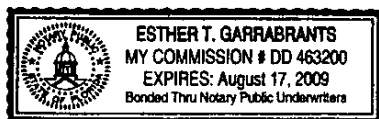
1. Roger St. Martin is the President of PHOENIX RISING REAL ESTATE, INC., a Florida corporation, (hereinafter "Corporation").
