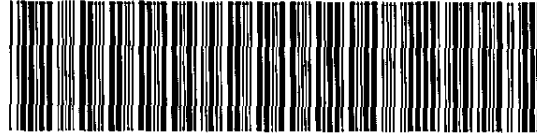

ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS

The name of this corporation is Fountain Homes & Contracting, Inc. and its principal place of business shall be located at 135 Aaron Strickland Road, Crawfordville, Florida 32327.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Restated Articles of Incorporation with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business, including residential construction.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue two thousand five hundred (2,500) shares of common stock at \$.01 par value, which shall be designated as "Common Shares."

ARTICLE V - REGISTERED OFFICE AND AGENT

The street address of the registered office of this corporation is 3119-B Crawfordville Highway, Crawfordville, Florida 32327, and the name of the registered agent of this corporation at that address is Frances C. Lowe.

ARTICLE VI - DIRECTORS

This corporation shall have two (2) Directors who shall serve until their successors shall be elected/appointed at the annual meeting of the stockholders and thereafter this corporation shall have no less than one (1) director no more than five (5) constituting the Board of Directors. The

This corporation reserves the right to amend or repeal any provision contained in these Amended and Restated Articles of Incorporation, or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation. These Articles may be amended at any time by a majority vote of the shareholders.

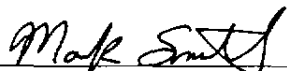
