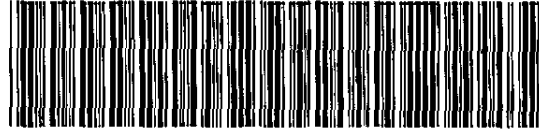

ARTICLES OF INCORPORATION

FOR

ALESTIN, INC.

Article I.

Corporate Name

The name of this corporation is Alestin, Inc.

Article II.

Nature of Business and Powers

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.

Article III.

Term of Existence

This Corporation shall have perpetual existence commencing upon filing of these Articles of Incorporation.

Article IV.

Capital Stock

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is one thousand (1,000) shares of common stock having no par value.

Article VI.

Board of Directors

This Corporation shall have two (2) directors initially. The number of directors may be increased or diminished from time to time by By-Laws adopted by the stockholders, but shall never be less than one.

Article VII.

Initial Directors

The name of the initial directors of this Corporation and their street addresses are: John H. Kokis and Rungsima V. Kokis, 364 Echo Circle, Fort Walton Beach, Florida 32548. The persons named as initial directors shall hold office for the first year of existence of this Corporation or until their successors are elected or appointed and has/have qualified, whichever occurs first.

Amendment
