

**ARTICLES OF INCORPORATION OF
LIGHTHOUSE FIRE & SECURITY CORPORATION**

ARTICLE I-NAME

The name of this corporation is LIGHTHOUSE FIRE & SECURITY CORPORATION.

ARTICLE II-DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III-PURPOSE

This corporation is organized for the purpose of contracting, design, installation, and monitoring of fire and security alarm systems and for transacting any and all lawful business permitted under the laws of Florida.

ARTICLE IV-CAPITAL STOCK


