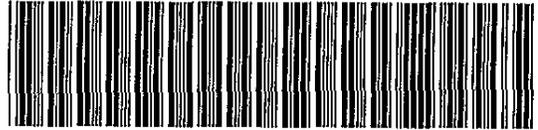

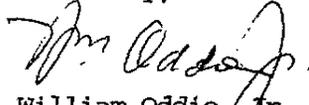

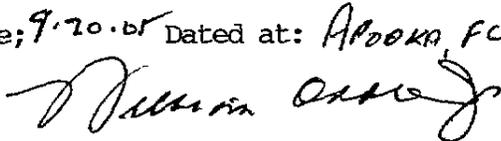

CERTIFICATE OF INCORPORATION  
FOR  
EAST TO EDEN, INC.

1. The name of this corporation is East TO EDEN, INC.
2. The principal office of the corporation will be located at 2118 Adams Ridge Road Apopka, Florida 32703. The registered agent will be William Oddie, Jr. at the same address.
3. The nature of the business is to do any and all things as fully and to the same extent as a natural person might and could do in any part of the world, VIZ: The purpose of this corporation is to engage in any lawful act or activity for which corporations may be organized under the General Laws of the State of Florida.
4. The authorized amount of capital stock is ten thousand (10,000) shares of stock with a par value of one dollar (1.00) per share.
5. The name and address of the incorporator is William Oddie, Jr. at the address in no. 2. above
6. The powers of the incorporator shall cease upon approval of the certificate by the state of Florida. The name and address of the person who will serve as the temporary director is William Oddie, Jr. at the address in no. 2. above.
