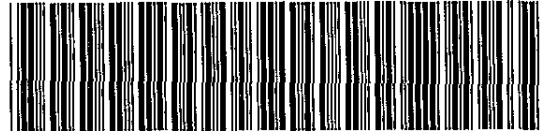

The undersigned hereby forms a Corporation under the following Charter of Articles of Incorporation:

**ARTICLE I
NAME**

The name of this Corporation shall be **SOUTH PALM BEACH COUNTY HOMES, INC.**
