ARTICLES OF INCORPORATION

OF

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation.

ARTICLE I

NAME AND ADDRESS

Section 1.1 **Name** The name of the corporation is Dana's Charter Service, Inc (the "Corporation").
