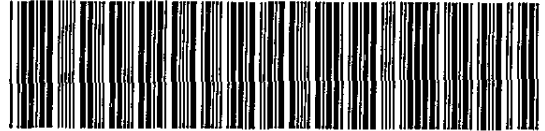

ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I
NAME AND PRINCIPAL OFFICE

The name of this corporation is Washed, Inc., and its principal office is located at 8276 Toledo Street, Navarre, Florida 32566, and its mailing address is the same.

ARTICLE II
DURATION

This corporation shall exist perpetually.

ARTICLE III
PURPOSE

The purpose of this corporation is to engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV
CAPITAL STOCK

This corporation is authorized to issue 10,000 shares of \$1.00 par value common stock, all of one class and series.

ARTICLE V
PREEMPTIVE RIGHTS

Every shareholder upon the sale of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without the issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI
INITIAL REGISTERED OFFICE AND AGENT

The street address of this corporation's initial registered office is 8276 Toledo Street, Navarre, Florida 32566 and the name of this corporation's initial registered agent is Harley J. Neal.

ARTICLE VII
INITIAL BOARD OF DIRECTORS

The number of directors may be increased from time to time by the bylaws but shall never be less than one. Officers shall be nominated and elected by the initial director. The initial director shall serve until the next annual meeting of the corporation. The election of officers and directors shall take place at the regular annual meeting of the board of directors. Officers and directors shall be elected for a term of one year. Officers shall be elected in the manner as set forth in bylaws of this corporation.
