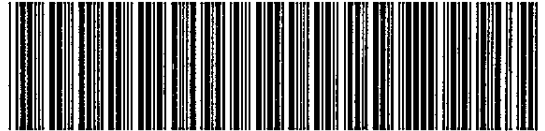


ARTICLE 4. CAPITAL STOCK
