**ARTICLES OF INCORPORATION
OF
LIQUID COWBOY, INC.**

ARTICLE I - NAME

The name of this corporation is **LIQUID COWBOY, INC.**

ARTICLE II - PRINCIPAL OFFICE

The address of the principal office and the mailing address of the corporation is 467 Jackson Avenue R, Cape Canaveral, Florida 32920.

ARTICLE III - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE IV - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes, as now exists or may after be amended.

ARTICLE V - CAPITAL STOCK

This corporation is authorized to issue 250,000 shares of One Dollar (\$1.00) par value common stock which shall be designated as "Common Shares."


