ARTICLE I. CORPORATE NAME

The name of this corporation is EAST COAST STORM SYSTEMS, INC.

ARTICLE II. NATURE OF BUSINESS AND POWERS

The general nature of this business is hurricane shutters sales and installation, and to conduct all business lawfully permitted under the Laws of The State of Florida and the United States.

ARTICLE III. CAPITAL STOCK

The stockholders shall determine the title and duties of each officer of this corporation.

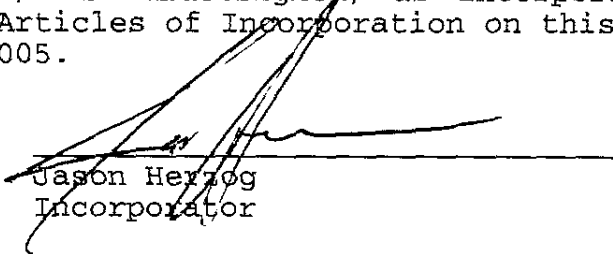
ARTICLE XI. REGISTERED AGENT FOR SERVICE OF PROCESS

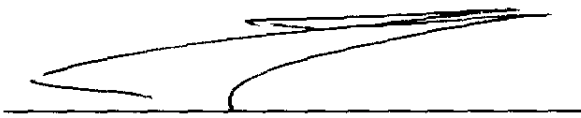
