

#### ARTICLES OF INCORPORATION

OF

The undersigned Incorporator of these Articles of Incorporation is a natural person competent to contract and hereby forms a corporation for profit under the General Corporation Act and other laws of the State of Florida.

#### ARTICLE I. NAME AND PRINCIPAL OFFICE

The name of this corporation is Florida Viro Import-Export, Inc. and its principal office is located at 5055-9 St. Augustine Road, Jacksonville, Florida 32207.

## ARTICLE II. DURATION

This corporation is to exist perpetually.
