To Whom It May Concern:


Today I received a card in the mail (Document P05000131020) stating that GSR and Associates, Inc. has been "administratively dissolved or revoked" due to not filing the 2006 annual report.

This was a shock and surprise to me, as this was not my intention. My corporation was newly formed this year, and I do not recall getting a notice that I needed to file anything. Had I gotten one I certainly would have done so.

During this past February I became very ill and spent 8 days in Intensive Care. Perhaps a card arrived then, and in the aftermath was overlooked or misplaced, if it did make it to this address.

I called the Division of Corporations and was told about a \$150 fee to reincorporate, and a \$600 late fee. I am asking that, if at all possible, the \$600 fee be waived.
