

The undersigned, acting as incorporator of a Corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I - NAME AND ADDRESS

The name of this corporation is NORTH FLORIDA PRESS, INC., and the street address of the initial principal office is 12034 Oak Street, Fountain, FL 32438, and its mailing address is Box 629, Fountain, FL 32438.

ARTICLE II - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE III - CAPITAL STOCK

This corporation is authorized to issue one thousand(1000) shares of One Dollar (\$1.00) par value of common stock, which shall be designated "Common Shares".

ARTICLE IV - REGISTERED AGENT AND OFFICE ADDRESS

The name of the initial registered agent is Tom Owen, whose address is 12034 Oak Street, Fountain, FL 32438.

ARTICLE V - MANAGEMENT BY SHAREHOLDERS

This corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

ARTICLE VII - TERM OF EXISTENCE

This corporation is to exist perpetually.




