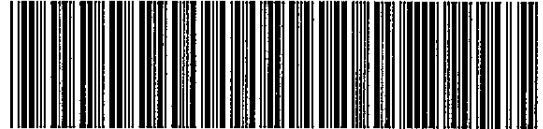

In compliance with the requirements of Florida Statutes, Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of this corporation is Tinseltown Entertainment, Inc.

ARTICLE II

The existence of the corporation shall begin on September 21, 2005.

ARTICLE III

The street address of the principal office of the corporation is 4372 Southside Blvd, Suite 207, Jacksonville, Florida 32216, and the mailing address of the corporation is P.O. Box 51433, Jacksonville Beach, Florida 32240.

ARTICLE IV

The corporation elects to have preemptive rights; and contrary to Florida Statutes, Section 607.0630(2)(c), shareholders of the corporation will have preemptive rights with respect to the shares described in Section 607.0630(2)(c).

ARTICLE VI

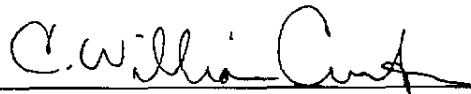
