ARTICLE I--NAME and PRINCIPAL PLACE OF BUSINESS AND INITIAL  
OFFICERS AND DIRECTORS OF THIS CORPORATION

ARTICLE II--DURATION

This corporation shall exist perpetually.

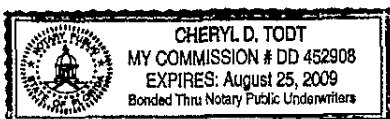


