

ARTICLES OF INCORPORATION

OF

Teman, Inc.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

Article I

The name of the corporation is: **Teman, Inc.** The principal place of business of this corporation shall be 8034 Sunport Drive # 406 & 407, Orlando, FL 32809.

Article II

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other State, or country.

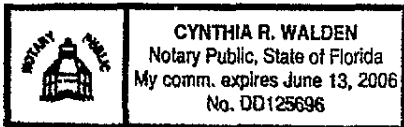
