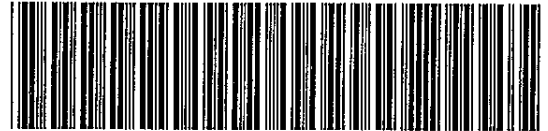



The undersigned, being a natural person, does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a business corporation pursuant to the provisions of the Florida General Corporation Act.

FIRST: The name of the corporation (hereinafter called the "corporation") is ZOOM LOAN INC.

SECOND: The address of the principal office and the mailing address of the corporation in the State of Florida is 9480 South Dixie Highway, Miami, Florida 33156.

THIRD: The aggregate number of shares which the corporation shall have authority to issue is one hundred (100), all of which are of no par value and are of the same class and are to be common shares, and without any provision for pre-emptive rights.


