ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a professional service corporation under Florida Law, and who is a natural person competent to contract, does hereby adopt the following Articles of Incorporation:

ARTICLE 1

The name of this Corporation shall be.

This Corporation shall have perpetual existence.

ARTICLE 3

This Corporation is organized for the purpose of rendering the specific professional service as a mortgage broker.
