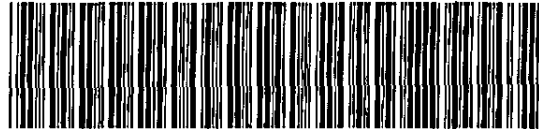

ARTICLES OF INCORPORATION OF  
CHRISTOPHER M.D. AND ASSOCIATES, P.A.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in the adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation is CHRISTOPHER M.D. AND ASSOCIATES, P.A.

ARTICLE II

The existence of the Corporation shall be perpetual.

ARTICLE III

ARTICLE IV

The street address of the initial principal office of the Corporation is 131 Redstone Avenue, Suite 107, Crestview, Florida 32539.

ARTICLE V

The maximum number of shares this Corporation is authorized to issue is 1000, par value \$1.00 per share, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote
