**ARTICLES OF INCORPORATION  
OF

The undersigned, for the purpose of forming a Corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation.

**ARTICLE I  
CORPORATE NAME AND PRINCIPAL OFFICE**

The name and mailing address of this Corporation is: Decopane, Inc., 1601 Blount Road, Pompano Beach, FL 33069.

**ARTICLE II  
TERM OF EXISTENCE**

This Corporation shall begin upon the filing of these Articles and shall have perpetual existence commencing on the filing of these Articles.

**ARTICLE III  
PURPOSE**

The general purposes for which the Corporation is organized are the following:

- a. To engage in and transact any lawful business for which Corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.
- b. To do such other things as are incidental to the purpose of Corporations or necessary or desirable in order to accomplish them.
- c. To engage in the operation of a business dedicated production and design of decorative glass products and to carry on any business necessary or incidental to the accomplishment or furtherance of the purpose or object of this Corporation.

**ARTICLE IV**  
**CAPITAL STOCK**

The aggregate number of shares which the Corporation is authorized to issue is One Thousand (1,000) Shares of common stock. Such shares shall be of a single class and shall have a par value of One Dollar (\$1.00) per share.

**ARTICLE V**


**ARTICLE IX**

The Corporation shall indemnify each officer and director, including former officers and directors, to the full extent permitted by law.


**ARTICLE X**
