ARTICLE I - NAME

The name of this corporation is Designer Kreations by Dina, Inc. The principal place of business shall be at 4367 Trevi Court, Lake Worth, FL 33467.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III - PURPOSE

The purpose of this corporation is to engage in any activities or business permitted under the laws of the United States and Florida.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares that this corporation is authorized to have outstanding at any time is 100 shares of common stock having a par value of Ten Dollars (\$10.00) per share.

ARTICLE V - INITIAL REGISTERED AGENT AND OFFICE
