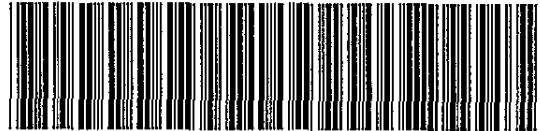

Article I - Name and Business Address

The name of this Corporation is ***San Star DY, Inc., a Florida corporation***. Its principal office address and business mailing address is 205 N.W. 136th Court, Miami, Florida 33182.


